**VOTING RESULTS OF THE ANNUAL GENERAL MEETING

The Board is pleased to announce that all resolutions proposed at the AGM were duly passed by the Shareholders by way of poll at the AGM held on 3 June 2016.

VOTING RESULTS OF THE AGM

The board (“Board”) of directors (“Directors”) of Tingyi (Cayman Islands) Holding Corp. (the “Company”) is pleased to announce that at the annual general meeting (the “AGM”) held on 3 June 2016, all the resolutions set out in the Notice of AGM dated 20 April 2016 were duly passed by the shareholders of the Company (the “Shareholders”) as ordinary resolutions by way of poll.

As at the date of the AGM, the total number of issued shares of the Company was 5,602,871,360 shares, which was the total number of shares entitling the Shareholders to attend and vote for or against the resolutions at the AGM. No shareholder of the Company was entitled to attend and vote only against the resolutions proposed at the AGM. None of the shareholders of the Company have stated their intention in the Company’s circular dated 20 April 2016 to abstain from voting for or voting against any of the resolutions at the AGM.

PAYMENT OF FINAL DIVIDENDS

In relation to the ordinary resolution No. 2 above, the final dividends will be paid on or before Wednesday, 6 July 2016 to shareholders whose names appear on the register of members of the Company as at Tuesday, 14 June 2016. In order to ascertain shareholders' entitlement to the final dividends, the register of members of the Company will be closed from Friday, 10 June 2016 to Tuesday, 14 June 2016 (both dates inclusive). To qualify for the final dividends, all properly completed transfer forms accompanied by the relevant share certificates must be lodged with the Company's Hong Kong branch share registrar and transfer office, Computershare Hong Kong Investor Services Limited at Rooms 1712-1716, 17th floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not later than 4:30 p.m. on Wednesday, 8 June 2016. Shareholders registered under the Hong Kong branch register of members will receive their dividends in Hong Kong dollars ("HK\$"). The HK\$ equivalent of the final dividend is HK\$0.1779 per share which is based on today's exchange rate of US\$ against HK\$ at US\$1.00 to HK\$7.7697.
